

The Clothing Tree Tagging Agreement

I _____ agree to have The Clothing Tree take my items for consignment and arrange for my items to be prepared for the current season's consignment event(s). While my items are not in my possession, I assume all risk and liability of my items that may occur, but are not limited to such things as fire, natural disaster, and theft. I agree to all fees outlined below that are associated with this tagging service. **The fee DOES include the Consignor Registration Fee.** Consignors who use this Tagging Service are encouraged to become a Team Member. The option to participate as a Team Member by helping during our events offer additional consignor benefits and is considered per location (if more than one location is being offered in a season). See website for details on early shopping and increased commission benefits for our Team Members.

The Preparer will be assigned by The Clothing Tree and will package toys/books, hang and tag clothing or linen items, and enter my items for sale, print and tag all items accepted for sale. **The Preparer is not responsible to clean items or organize clothing by size and gender. The Consignor is responsible to go through clothing items prior to meeting with the Preparer and insure that any clothing items with staining (even small stains) have been removed from items delivered to the Preparer.** The Consignor will ensure that items brought to Preparer have been freshly laundered, wiped clean, have working batteries, and are in excellent condition. Consignors will also remove the fabric of items such as strollers, car seats, baby swings and launder them prior to bringing them to the Preparer. Consignor will deliver items in bins or boxes to the Preparer (larger items do not need to be in a box). If applicable, Consignor may also deliver additional items to the Preparer in between the two events of a single season and there will be no additional fees beyond the standard 20% deducted from total sales. The Consignor acknowledges that TCT and the Preparer have final say as to an item's acceptable condition for the event.

Fee structure:

- **There is an upfront seasonal fee for the tagging service package of \$30 payable online prior to your appointment with the Preparer.** This fee includes the following for an unlimited number of items:
 - ◆ Consignor Registration Fee
 - ◆ Storage of items prior to event
 - ◆ Tagging supplies such as cardstock, printer ink, tape, safety pins, bags, zip ties, and some hangers. Consignors are asked to bring any hangers they have on hand to the Preparer. (\$10 value)
- **The Tagging Service Consignor will have a base commission of 40%.** This is a 20% deduction from a "regular" DIY Consignor who normally has a base commission of 60%. Consignor can help as a Team Member during the sale to increase their own commission. (Please see our website for details.)

Discount and Donation of unsold or unaccepted items:

The Consignor acknowledges that the Preparer will be inspecting items as part of the tagging service preparation. Any items not accepted for consignment will go to direct donation, they will not be held or returned to the consignor. For acceptable items, the consignor will indicate below whether items will be marked for discount and/or donation.
